Dear Homeowner,

The Board of Directors has approved the purchase of a new control system for the gates to enter White Horse Park. Your old swipe cards will become inactive as of December 1st, 2012 at 7:00AM. Also, any type of remote control for the gates will no longer operate; this includes the remote that you may have purchased from White Horse Park.

Your new card(s) do not have to be swiped. They are proximity cards (or prox cards), which means that you need only wave the card in the area of the sensor. Whether or not you will have to open your window depends on a number of factors including window tint, weather conditions, distance to the sensor, etc.

The issuance of new cards will be handled as follows – each homeowner will be issued one (1) card when you return the enclosed questionnaire; if you want the card mailed to you, you must send us a stamped self addressed envelope; if you want a second card, you must request it and send a check for \$5.00 (five dollars); additional card requests will be handled on a case by case basis, and will cost \$15.00 (fifteen dollars) each; if you lose a card, a replacement will cost \$25.00, and the original card will be de-activated.

We are hoping that this new system will make White Horse Park a safer, happier place, and that it may help to decrease the unauthorized use of our pool, dumpsters, etc.
